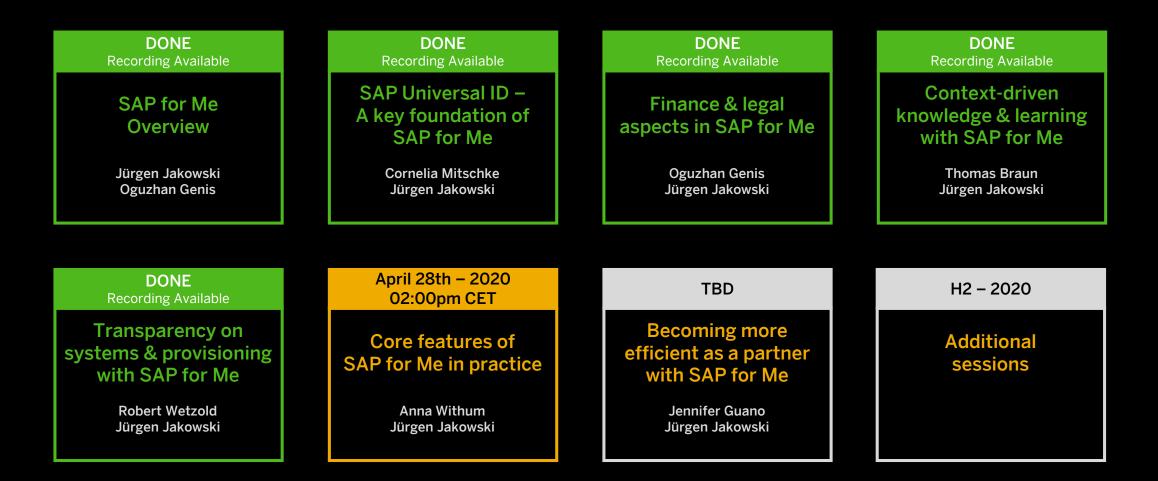

Our Scope

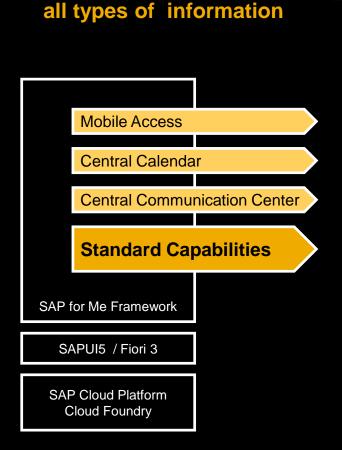




All people interacting with any digital SAP channel

- **View** / **inspect** SAP community notifications
- View / inspect SAP support notification
- View / inspect CAC notifications

Mobile Access (Smartphones)

- Consume all desktop scenarios (responsive UI)
- View / inspect notifications (including push notifications)
- View / inspect urgent activities
- View / inspect events


