



## Planning and Setup for SAP BTP operations



#### **Governance Model**

- Team setups (including IT support roles and responsibilities)
- Onboarding process for development projects
- Knowledge transfer process for the involved teams
- Support processes, operations documentation, and involved tools
- Define activities to ramp up resources and implement changes
- Help desk processes, incident and change management



#### **Account Model**

- Hierarchical structure between global accounts, directories, and subaccounts
- Staged development environment
- Cost management
- Automation



## Security and Compliance

- Authentication (User Store, IAS/IDP, Platform vs. Business Users)
- Authorization (Role Templates, Roles, Role Collections, Attributes)
- Identity propagation / SSO
- On-prem connectivity (SAP Cloud Connector)
- Data Protection and Privacy Requirements



## **BTP Account Model**




## Change management: Using a staged development landscape

## **Development landscape**

- Based on Continuous Integration principles, managed by DevOps team
- Verification of single developer change
- Typically fully automated


## **Delivery landscape**

- Based on strict Transport Management rules (policies, schedules), managed by ops/approvers
- Verification of release candidate version
- Typically done with manual confirmation



## **Global Account and Subaccount Security**

Fine-granular authorization concept for the management of global accounts



# Global/Sub- account membership is determined by the assignment of a role collection

- Member management refers to managing permissions for platform users.
  NEW: Support for custom identity provider (IDP)
- Members' permissions apply to all operations that are associated with the global account, the organization, or the space, irrespective of the tool used.



## Predefined <u>role collections</u> for global account define full and read-only access

- Global Account Administrator | Global Account Viewer
- Subaccount Administrator | Subaccount Viewer
- Directory Administrator | Directory Viewer



## Define your own role collections with the authorizations delivered by SAP

- The predefined default role collections contain predefined roles. They're based on <u>role templates</u>, which are provided by applications. The application identifier refers to the application, which provides the role templates.
- Role collections available in the global account don't necessarily exist in the subaccounts.

## **Entitlements**



## Manage entitlements for both services and multitenant applications

 If you have cloud credits, then you are eligible to subscribe to any multitenant application that is available to your global account in the Cloud Foundry environment.



## Assign entitlements to subaccounts individually

- Global Account → Entitlement → Entity Assignment
- Global Account → Entitlement → Service Assignment (View)
- Subaccount → Entitlement



## Assign entitlements to directories

- Directories to group subaccounts → assign entitlements to a directory
- Option to automatically assign a certain amount of quota to each subaccount added to that directory
- Like in subaccounts, quota assigned is shown as used, even if there are no subaccounts in that directory ("reserve")











## Usage Information for the Main Entities

#### Global Account - Subaccount - Service






#### Usage view per service

- Usage data for consumed services along rate plan and month
- Service usage data for global account, sub-account and space level (CF only).

## Global Account Costs



- Check on Service Plan level aggregated usage
- Cross-check costs on aggregated level with Estimator or for historical prices with price list



## **Subaccount Costs** by Service



- Check costs on service plan level by distribute the Global Account Service Plan cost by the actual usage of the Subaccounts
- Charge Subaccount costs to owner like subsidiaries or projects (e.g. cost center, profit center, WBS element, etc.)




