SAP Universal ID Overview

- The new user / identity foundation is built on SAP Universal ID.
- > The SAP Universal ID framework allows for a user identity to evolve over time.

With one SAP Universal ID, users can:



✓ own their personal SAP identity for life;



✓ add multiple email addresses to their SAP Universal ID;



✓ change companies or move to a different company subsidiary;




✓ keep their reputation, training, interests, and personal data in the near future.

Other key takeaways:

- ✓ An email address may only be associated with one SAP Universal ID, though multiple email addresses can be associated with one SAP Universal ID.
- ✓ The legacy user types (S-users) become attributes of the SAP Universal ID and function as authorizations.
- ✓ P-users become completely deprecated and are only used for content migration or legacy continuity.
- ✓ All user registrations will eventually be replaced by SAP Universal ID.
- ✓ Creation is end-user driven.


Objectives

- ✓ Users who do not have an SAP Universal ID account and attempt to login will be prompted to convert to SAP Universal ID within SAP.com

















Content Consolidation Tool URL
